Airline

- 19 To make organized groups, MBL / Travel Agent will arrange **seats in scheduled airline** from Karachi only. Customers will fly from their respective domestic stations (where required/opted) to Karachi and then they will proceed for **KSA in groups**. However, Meezan Bank (in case of seats availability) may also arrange direct flights from LHE/ISB as per Bank's discretion.
- 20 In case of any **change in airfare / taxes**, customer will pay the actual differences **before departure** at any MBL branch or at the Airline counter at the airport. Airfare applies as per travelling date of customer.
