## Terms & Conditions

**Disclaimer:** To undertake liability of loan for a "Naflī Ibadat" is preferred in Shariah. However, based on your personal needs If you decide to pay in installment then you may apply.

- 1 The Bank is an agent of the Travel Agent to sell its packages on Travel Agent's behalf to the customer, and in case the customer pays the package price in installments he becomes indebted to the bank, since bank pays the price to the travel agent in advance on Customer's behalf .
- 2 The Bank shall incur some additional costs for payment to third parties for verification and credit assessment etc. on customer's behalf. The customer will have to bear the actual charges for these expenses.
- 3 The package selected by the customer will be payable in 12 monthly installments or upon demand by the Bank.
- 4 Application form alongwith all original documents and initial deposit should be submitted for case processing. Initial deposit will consist of 25 % of package price as minimum down payment and as specified by the Bank from time to time. Processing time for each case will approximately be 20-25 working days.
- 5 Meezan Bank reserves the right to accept or reject any or all applications without assigning any reason and the applicant(s) / pilgrim (s) waives its rights to raise any claims or objections thereagainst.
- 6 All customers will be kept informed about their case status from time to time & they can take back their original documents from concerned branch after processing. In case of delay in endorsement of Visa from Royal Consulate of Saudi Arabia-Karachi, original documents would be delivered at a convenient place or at departure time on airport whereas PNR (airline reservation code) will be furnished to customer after which the tickets can be collected from any travel agent or airline office.
- 7 The stay in Kingdom of Saudi Arabia will be as per the selected package, therefore no Customer will be allowed to make their own arrangement unless it is agreed prior to departure for umrah or package for other duration by Travel Agent is selected.
- 8 Saudi government policies and rules apply, once the customer reaches there.
- 9 Under any circumstances, Bank's / Travel Agent's liability shall not exceed the amount deposited by the customer for the package with the Bank at any given point of time.

- 10 In case of withdrawal or change of schedule due to any reason, Customer will have to pay the actual withdrawal charges as set by the Travel Agent from time to time and will be available upon request from the branch.
- 11 Fees and charges are applicable as per Bank`s latest schedule of charges.
- 12 Application form alongwith all original documents should be submitted for case process.
