LAHORE: Punjab Emergency Services (PES) has suspended Dr Farzand, District Emergency Officer (DEO), Rescue 1122, after Punjab Home Department recommended disciplinary action against him on charges of corruption and power abuse, The News has learnt.

The Punjab Home Department has recommended disciplinary action against Punjab Emergency Services (1122) official on the charges of corruption, power abuse, The News has learnt.

According to the document, the disciplinary action has been recommended against co-accused, including M/s Adeel Aslam Rescue and Safety Officer (BS-16), Roohul Ameen Control Room Incharge (BS-16), Qaisar Saleem (BS-14) and Mahmood Khan Senior Store Keeper (BS-11) Rescue 1122.

MANSEHRA: Two girls and boy were killed and another girl suffered critical injuries when the boundary wall of the second story of a house collapsed in Shania Bala Dival area of the district here on Tuesday evening. "Three girls and a boy from my family, all stated to be cousins were buried alive under the rubble of the collapsed building and three of them were retrieved dead later," Moharrar Sabir, the relative of the girls told reporters.

Talha Nawaz and his cousins Shabana Safee, Ramsha Sajid, and Sadia, a between six to eight years of age, were playing in the house of Mohammad Nawaz when the boundary wall of the second floor collapsed and buried all of them under the rubble. The locals shifted them to a nearby hospital where doctors pronounce three of them dead.
