Resolution in Senate of Pakistan for Promotion of Islamic Banking



The Senate of Pakistan has unanimously passed a resolution for the promotion of Islamic banking. It further states that atleast 30% of all new Government debts should be replaced with a Shariah-compliant mode. Additionally, the suggestion for replacing or investing the funds related to Hajj, Zakat and Usher of the Ministry of Religious Affairs & Interfaith Harmony under a Shariah-compliant mode was also made.

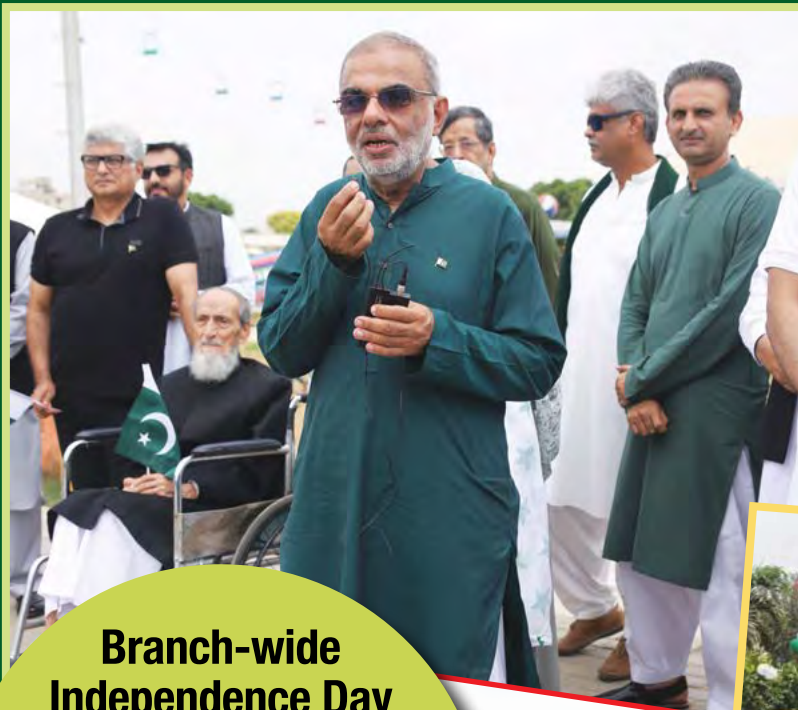

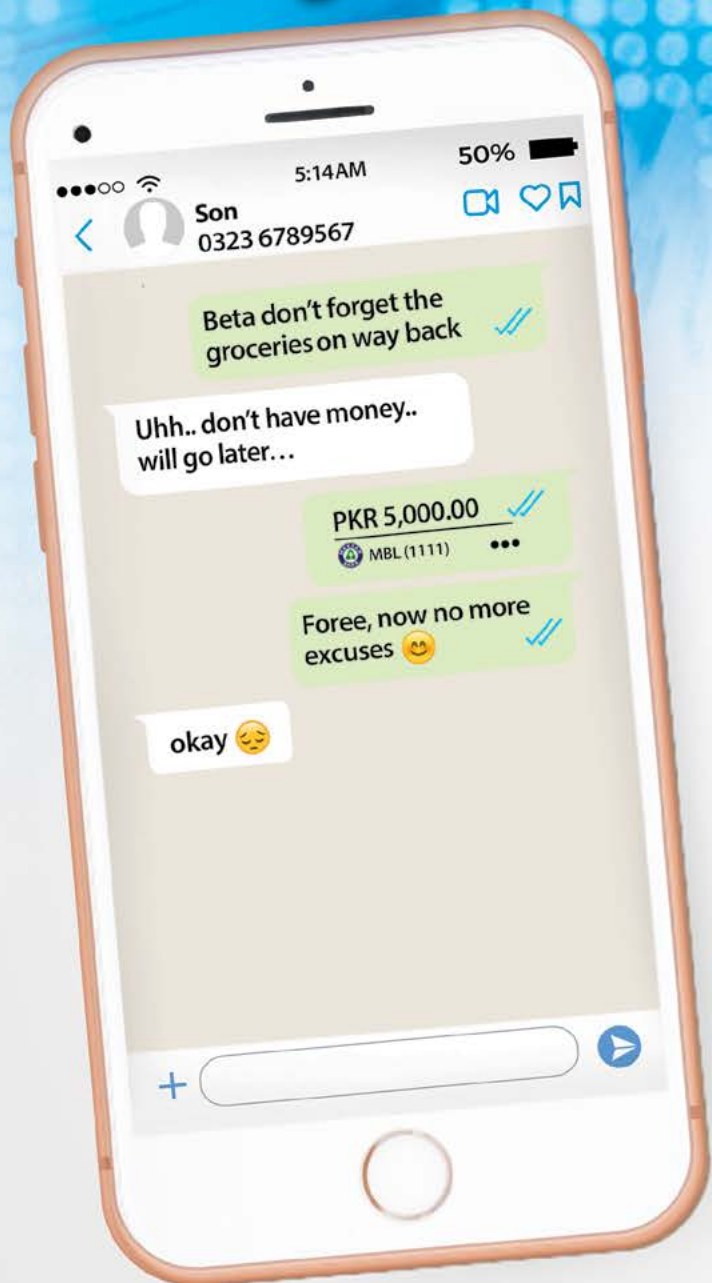

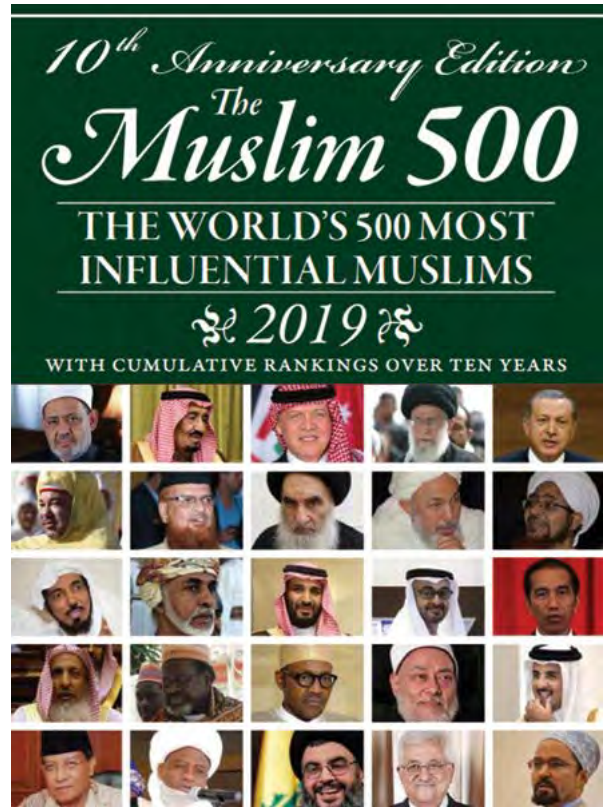
